Non-Native Speakers of English. All applicants, regardless of citizenship, whose first language is not English, must submit a **valid** minimum score of 6.5 on the International English Language Testing System **Academic** (IELTS), 79 on the Internet-based Test of English as a Foreign Language (TOEFL), 58 on the Pearson Test of English - **Academic Academic** (PTE-A), 3.9 on the International Test of English Proficiency-Academic (iTEP), or 176 on the Cambridge Assessment English C1 Advanced (C1 Advanced) **at taken within the time of application, preceding two years;** unless they have received a **bachelor's or** graduate degree from an accredited U.S. **college graduate school;** or **university, or receive a waiver of the English Language proficiency requirement by the Graduate Council Academic Appeals Committee by demonstrating an acceptable level of language proficiency as defined in the Graduate School Handbook located on the Graduate School Web site. The Duolingo English Test (DET) with a minimum score of 105, evidence of English Language Proficiency they have demonstrated by a "B" or better on the West African Senior School Examination Certificate (WASSCE), the General Certificate of Secondary Education (GSCE), the International General Certificate of Secondary Education (IGSCE), or the International Baccalaureate (IB) may be used on a case-by-case basis to fulfill the English Language Proficiency requirement with approval of the Graduate Dean. Applicants, regardless of citizenship, whose first language is not English and who are admitted to graduate study at the University of Arkansas, are required to present an acceptable score on one of the following tests: TOEFL (Writing), IELTS **Academic** (writing), PTE-A (writing), iTEP (writing), C1 Advanced (writing), GRE (analytical writing), GMAT (analytical writing) or **the Duolingo (writing) test on a case by case basis with approval of the Graduate Dean.** ~~ELPT (writing).~~ Depending upon exam scores, a student may be required to take one or more ELAC course(s) during their first term of study. ~~Students may be required to take the English Language Placement Test (ELPT) prior to the beginning of classes in their first term~~

of study: Non-native speakers in the following categories are exempt from this requirement, although individual departments may require any of these tests for admission. (Please note that those students who will be in graduate assistantships in which they will have direct contact with students in a teaching or tutorial role must still demonstrate proficiency in spoken English, even if they qualify for one of these exemptions.)

Graduate students who earned bachelor's or master's degrees **from accredited in** U.S. institutions or **from in** foreign institutions where the official and native language is English;

Graduate students with a **4.0 4.5** on the analytical writing portion of the GRE or a **4.5 5.0** on the writing portion of the GMAT.

Diagnostic and placement testing is designed to test students' ability to use English effectively in an academic setting, and its purpose is to promote the success of non-native speakers in completing their chosen course of study at the University of Arkansas. Test results provide the basis for placement into English Language and Culture (ELAC) support courses or course sequences. Courses are offered by the Graduate School and International Education for those students whose language skills are diagnosed as insufficient for college work at the level to which they have been admitted (undergraduate or graduate study). Credit in ELAC courses may not count toward University of Arkansas degrees. Non-native speakers diagnosed as having language competence sufficient for their level of study will not be required to enroll in ELAC courses.

~~The ELPT is administered by Testing Services during New Student Orientation and there is a \$15 charge.~~ Graduate students assessed course work as a result of performance on the ~~ELPT~~, TOEFL writing, IELTS **Academic** writing, PTE-A writing, iTEP writing, C1 Advanced writing, GRE or GMAT analytical **writing, or DET writing** will be required to complete the ELAC course(s) to support initial course work taken in their fields. Graduate departments/degree programs will have the discretion to waive either the requirement for the language evaluation or the required language courses.

It was approved in February 2020 to be used for the contact GA requirement, though there are still inconsistencies in test results. DET was supposed to be only for case by case basis when other exam options were not available (ie during pandemic). There are multiple options available to students once they are admitted to fulfill the contact GA requirement.</p> <p>4) The Graduate School has had a long policy of "recommending" ELAC courses to students in certain score bands and then "requiring" for students in lower score bands. Data shows that the majority of students who are recommended to take ELAC courses do not and those that do have minimal difference in academic outcomes from those that do not. Therefore, to make the process more efficient and easier for student/faculty to understand, we are eliminating the recommended bands and instead resetting minimum test scores to the already approved required bands. The change therefore is minimal--anyone who previously was required to take ELAC is still required to take ELAC. The recommended is the only elimination.</p> <p>5) ELPT is an in-house testing option for students to meet writing requirement. This exam is cumbersome and costly to administer and no other SEC or benchmark school offers an in-house option. Testing Services will no longer administer this exam after Spring 2022 so we are updating catalog to reflect that change.</p>
